Tory Failure Carousel

We're finally down to the final two of what has been a bleak selection of Tory MPs jostling for the leadership with no idea, no plan to get us out of the difficulties of our economy.

The Tory candidates who have put themselves forward have been no strangers to me as I have shadowed both <u>Liz Truss</u>, and <u>Suella Braverman</u>. Frankly, the experiences were eye-openers to the new depths that Tory incompetence and deceit could plumb.

In my previous role as Shadow International Trade Secretary, I have requested the most basic details of Truss's meetings in the public interest to only receive evasive and opaque replies from her department. A Liz Truss leadership would be no different to Johnson's degradation of public trust.

As Shadow Attorney General, I see firsthand the incompetence of Suella Braverman as rape prosecution delays grow and the national increase in fraud goes untackled. During Attorney General Orals, Braverman does not even have the pretense of accountability and would much rather rant about political theory like a panicked sixth-form debater.

There is a culture of cover-up and deceit across the whole of this government that will not be ended simply by replacing Boris Johnson, and the attempts to hide basic facts and dodge scrutiny shows how deeply that culture is ingrained.



Violence Against Women & Girls

In June, I led more than 100 female Labour MPs in signing a letter to the Prime Minister calling for him to scrap the new guidance on pre-trial therapy for rape victims. The proposed changes will make it far too easy for defence teams to access and use therapy notes in rape trials.

It will cause many survivors to avoid seeking therapy, and make it more likely that cases will collapse when the prolonged stress of waiting for trials becomes too much.

Boris Johnson wasn't aware of the proposed changes. This government pays so little attention to violence against women and girls with the huge court backlogs that see victims wait over 1,000 days for trial.

In Islington, I have been meeting local stakeholders like Abianda to discuss the changes in guidance and the difficulties of abysmal prosecution rates, and trial delays.

While the Tories are discussing 20% cuts to the civil service, victims are caught up in a broken, backlogged system. We drastically need a government that will act on this.

Emergency Services Waiting Times

Accident & Emergency is the canary in the coalmine for the NHS, and indeed the rest of our public services. People are struggling to see their GP and current patients in hospitals struggle to return home without a functioning social care system. As a result, A&E carries the burden and ambulance waits have climbed to an appalling 40 minute wait, and trusts are regularly warning patients that there may be no help at peak times.

The Tories have mismanaged our National Health Service and now, the entire weight of a failing system is resting on the Ambualance Service as it picks up many issues that ought to have been resolved through general practice, social care, or mental health provision.

Last week I visited the London Fire Brigade and saw first hand the efficiency and effectiveness of our Fire Service. You can expect a fire crew to arrive in under 8 minutes. Previously, you could expect an ambulance in reasonable time! This is a far cry from our Tory-run, underfunded Ambualance Service.

I am proud of my team's actions in helping save a longplanned performance by world-class Ukrainian violinist Valeriy Sokolov with Islington-based orchestra Aurora Orchestra from cancellation. We stepped in to resolve a long-running visa issue for soloist Valeriy Sokolov so he could perform Tchaikovsky's Violin Concerto with Aurora Orchestra in the Royal Festival Hall on Friday 24th June.

Valeriy has had a tumultuous few months as he was forced to flee his hometown of Kharkiv as it suffered heavy bombing during the Russian invasion.

It was such a joy to see Valeriy share his wonderful talent with a live audience here in London, and such a pleasure to support the fantastic Aurora Orchestra, who add so much to the cultural life of our borough and our city.
