It was fantastic to see first-hand the positive work of midwives, doctors, and hospital staff. It was especially great to learn that 3850 lives began in the unit last year!

I am also pleased to hear of the expected investment and plans for refurbishments of the maternity and neo-natal facilities.



International Criminal Court Visit

The UK has a duty to help the people of Ukraine fight Russia's illegal war of aggression, including by ensuring there is legal accountability.

That's why, at the start of October, in my role as Shadow Attorney General, I was honoured to visit the International Criminal Court (ICC) in The Hague. While there, I discussed with experts how the UK can ensure that President Putin and his cronies and military leaders can be prosecuted for the crimes they have committed in Ukraine.

What really stood out for me at the ICC was the huge commitment that has been made by the international community to ensuring prosecutions can take place. There has been a vast increase in financial and other forms of support for the Court since the invasion began.

Unusually, the Chief Prosecutor has launched an investigation while the conflict is still ongoing, to try and ensure that justice is swift. If this model is successful, it will hopefully provide a template for prosecuting future conflicts, in addition to making Russia and others who might want to commit such atrocities think twice in the future.
